Membership Requirements

North American Headquarters

Membership in ECIA is open to the three key elements of the electronic components industry: manufacturers, authorized distributors and independent field sales representatives. Together we will work to be a stronger voice for our entire industry.

Distributor membership is open to those business entities engaged in the wholesale distribution of electronic components, equipment, and supplies. To qualify for distributor membership, a majority (over 50%) of a company's business must be contractually authorized (by the manufacture/s) to re-sell electronic components, materials, systems and assemblies.

Manufacturer membership is open to those businesses that manufacture, or have manufactured for them, electronic components, equipment or supplies.

Independent Field Sales Representative membership is open to those businesses that are contractually retained by manufacturers to market and sell electronic components, equipment or supplies.

Annual Dues

The ECIA dues structure for distributor and manufacturer membership is based on a percentage of dollar sales of electronic components in North America. Representative member dues are based on total revenue. *

Less than \$50 million	\$ 1,000
Between \$50 M and \$100 million	\$ 1,500
Between \$100 M and \$250 million	\$ 3,750
Between \$250 M and \$500 million	\$ 7,500
Between \$500 M and \$750 million	\$ 11,250
Between \$750 M and \$1 billion	\$ 15,000
Greater than \$1 billion	\$20,000

* Dues amounts apply to new members only. ECA and NEDA member dues will be based on current dues levels.
